選舉權的居民資格限制

- 選舉權的群體性、集合性
- 真實居住 (bona fide residence) v. 一定期間之居住 (durational residence)
- 選舉法上真實居住的概念與認定，應該與時俱進，而非全盤揚棄。

Am I eligible to vote?

Each state has slightly different rules for who is eligible to vote. Generally, you must be:



A citizen of the United States



A resident of the community where you would like to vote (sometimes for a minimum amount of time)



At least 18 years old (in some communities, people under the age of 18 can register and vote in certain local or primary elections)

In some states, but not all, individuals may be disqualified from voting due to a felony conviction, judicial ruling, or other procedure. Contact your state or local election officials if you have questions about your eligibility to vote. To find your local election officials, you can go to www.vote.gov.

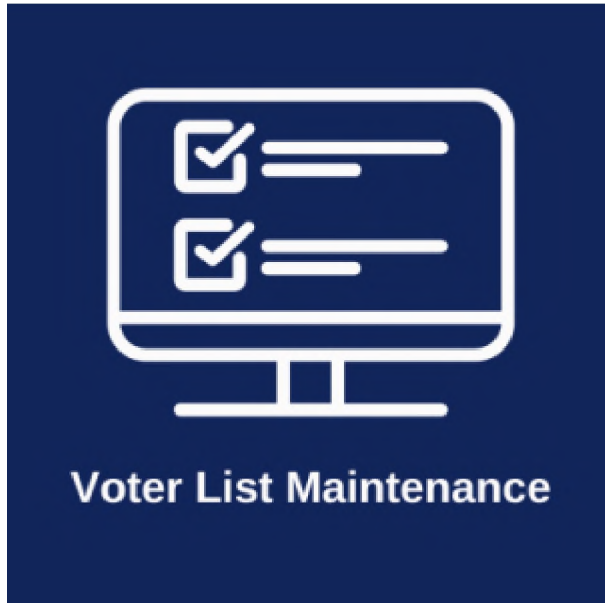

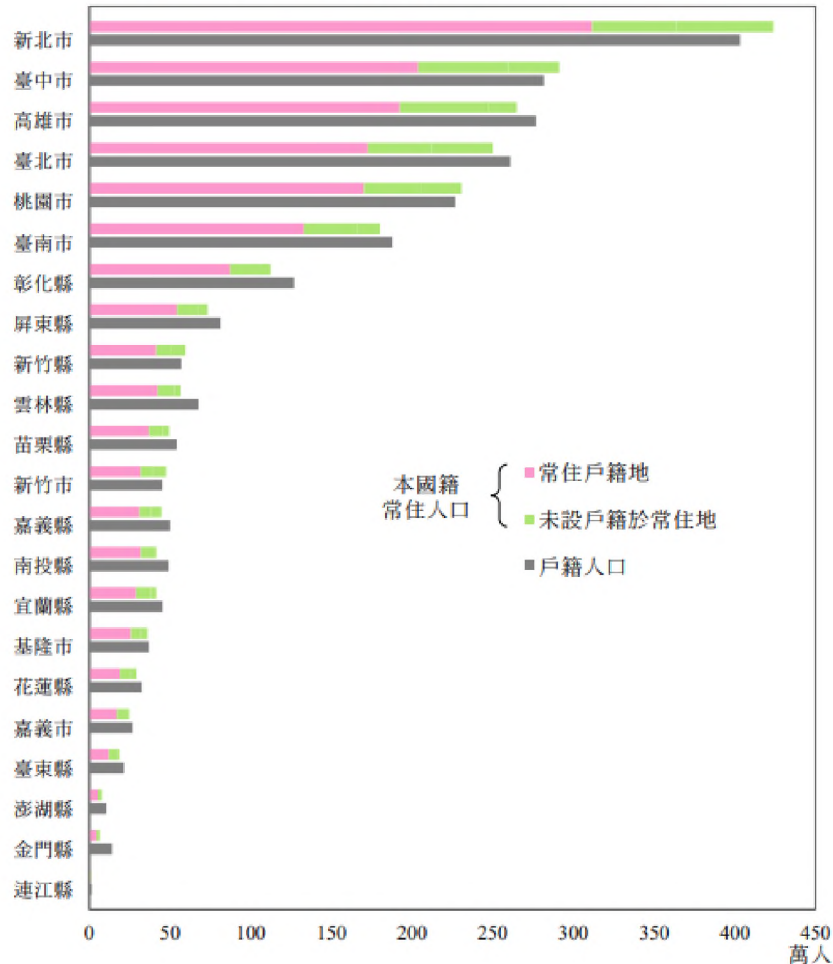

- 主要非為選舉目的而將戶籍地址登記於非真實居住地的情形，可以不算是選民登記詐欺。
- 系爭規定二未處罰所有[類型C]的行為人，是否構成違憲，還有討論空間。
